### **6. INSURANCE**

6.1 Vendor shall maintain appropriate insurance coverage for its booth and activities at the Event.

### **7. TERM AND TERMINATION**

7.1 This Agreement shall commence on the Effective Date and shall terminate upon the completion of the Event.
